

**RELEASE OF LIABILITY AGREEMENT - MINOR**

**The undersigned volunteer hereby agrees to and does release The Gress Mountain Ranch,) from any and all liability arising out of the volunteer’s service to The Gress Mountain Ranch, including, but not limited to, all liability arising out of the volunteer’s handling of and contact with any animals within the possession, custody or control of The Gress Mountain Ranch whether or not such animals are on The Gress Mountain Ranch’s property.**

The Volunteer agrees further that as used in this agreement, the term “Volunteer” includes the undersigned, and his/her heirs, assigns and legal representatives, and that the term “The Gress Mountain Ranch”, includes all past, present, and future officers, directors, employees, and agents of The Gress Mountain Ranch, including their heirs, assigns, and legal representatives.

**VOLUNTEER AGREES AND ACKNOWLEDGES THAT HE/SHE ASSUMES ALL RISKS INCIDENT TO HIS/HER SERVICE TO THE GRESS MOUNTAIN RANCH INCLUDING, BUT NOT LIMITED TO, HIS/HER PRESENCE ON THE GRESS MOUNTAIN RANCH’S PROPERTY AND THE HANDLING OF AND CONTACT WITH ANY ANIMALS WITHIN THE POSSESSION, CUSTODY OR CONTROL OF THE GRESS MOUNTAIN RANCH.**

I hereby understand and acknowledge that, unless otherwise defined by applicable law, any Volunteer relationship with The Gress Mountain Ranch is of an “at will” nature, which means that the Volunteer may resign at any time and The Gress Mountain Ranch may discharge the Volunteer at any time with or without cause.
